



**WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT
2024-2025**

In consideration for receiving permission to participate in the Covenant Light Private School & Co-op meeting at First Baptist Church of Mt. Dora.

As a guest of Covenant Light Private School & Co-op (CLSC), I, _____ hereby release, waive, discharge and covenant not to sue First Baptist Church of Mt. Dora or Covenant Light Private School & Co-op, INC., its officers, and agents (hereafter referred to as “releasees”) from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or relating to any illness, loss, damage, or injury, including death, that may be sustained by me or my child(ren), or to any property belonging to me and/or my child(ren), whether caused by the negligence of the releasees, or otherwise, while participating in the Co-op/Field Trip/Special Events, or while in, on or upon the premises where the Co-op/Field Trip/Special Event is being conducted, while in transit to or from the premises, or in any place or places connected with the Co-op/Field Trip/Special Event.

I am fully aware that I (we) are not First Baptist Church of Mt. Dora or CLSC members and are therefore not covered by any insurance or benefit otherwise entitled to First Baptist Church of Mt. Dora or CLSC., and I am aware of risks and hazards connected with being on the premises and participating in the Co-op/Field Trip/Special Event, and are fully aware that there may be risks and hazards unknown to me connected with being on the premises and participating in the Co-op/Field Trip/Special Event, and I (we) hereby elect to voluntarily participate in the Co-op/Field Trip/Special Event, to enter upon the above named premises and engage in activities knowing that conditions may be hazardous, or may become hazardous or dangerous to me and/or my child(ren) and my (our) property. I voluntarily assume full responsibility for any risks of illness, loss, property damage or personal injury, including death, that may be sustained by me and/or my child(ren), or any loss or damage to property owned by me and/or my child(ren), as a result of my being a participant in the Co-op/Field Trip/Special Event, whether caused by the negligence of releasees or otherwise.

I further agree to indemnify and save and hold harmless the releasees and each of them, from any loss, liability, damage or costs they may incur due to my (our) participation in the Co-op/Field Trip/Special Event, whether caused by the negligence of any or all of the releasees , or otherwise.

It is my express intent that this Release shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a Release, Waiver, Discharge and Covenant not to sue the above names releasees.

In signing this release, I acknowledge and represent that:

- A. I have read the foregoing release, understand it, and sign it voluntarily as my own free act and deed;
- B. No oral representation, statements or inducements, apart from the foregoing written agreement, have been made;
- C. I am at least (18) years of age and fully competent (or parent/guardian of minor child); and
- D. I execute this Release for full, adequate and complete consideration fully intending to be bound by same.
